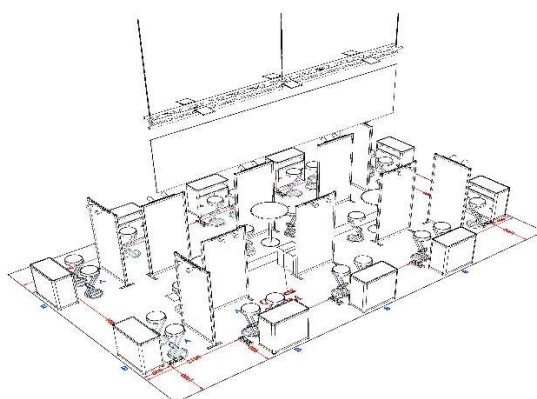




Special Offer: Exhibit in the PADI Village

For the 28th edition of the Paris International Dive Show, taking place from **Thursday 14 to Sunday 17 January 2027** at the **Paris-Porte de Versailles** Exhibition Center, we are pleased to offer, in collaboration with PADI EMEA, a dedicated booth area reserved exclusively for **PADI Dive Centers**.

1/ The booth and package included in the reservation



The reservation includes:

- Registration Fees & Insurance
- A 6m² space
- Recyclable Carpet
- White melamine partitions (1.00m x height 2.40m) with one-sided four-colour printed signage - Size 940mm x 2246 mm - (*HD visuals to be supplied**)
- Lighting rail with 2 spotlights
- Block of 3 electrical sockets connected to a power supply
- 1 lockable counter with one shelf and one-sided four-colour printed signage - Size 840 mm x 1020 mm (Image supplied by PADI EMEA)
- 2 stools
- 1 Wi-Fi Connection
- 6-metre light bridge with signage - Size 5500 mm x 1500 mm (Image supplied by PADI EMEA)
- Waste removal, cleaning the day before opening and every morning before doors open to the public
- 4 client invitations
- 3 exhibitor access badges

The booth also features a shared common area with three high tables and stools, providing a welcoming space for meetings.

Position in the Hall:

The PADI Village booth is ideally located in the center of the Hall, next to the PADI EMEA institutional booth, between two main 4-metre aisles.



Price & TVA:

Price for the booth all inclusive: €3,100.00 excl. VAT

There is 20% VAT, giving a total price of €3,720 including VAT.

However, if your company is based abroad, whether or not established in an EU Member State, is a taxable professional, the registration will be invoiced exclusive of VAT. In practice, EU customers with an intra-Community identification number (verifiable on the VIES database) or non-EU customers whose actual professional activity is evidenced (and can be verified) by elements such as commercial documents, a website, a professional registration, etc. may be considered as taxable persons. In this case, the customer invoiced exclusive of VAT will self-charge (i.e. calculate, declare and pay) the VAT in the State in which he is established.

Please note: this special offer is only valid for PADI Dive Centers exhibiting within the PADI Village. A PADI Dive Center wishing to exhibit on another booth or on its own booth cannot benefit from this package or the associated special rate.

2/ Registration & deadline

You must register online at the Paris Dive Show website : www.salon-de-la-plongee.com .

You can choose between French and English pages.

The deadline for registration is Tuesday, 15 September 2026.

A/Process for exhibitors who have already participated at the show:

- Log in to the show website on the *Espace Exposant / Exhibitor Space* page: <https://www.salon-de-la-plongee.com/fr/exposer/espace-exposant.html>
- Enter the address you used to register for the show in the box “*Email of responsible*”
- Enter the password you received when you confirmed your registration in a last edition. If you have lost it, click on “*Forgot password*” and a new code will be sent to you immediately by email.

- On the “*Choose Registration type*” page, click on “*You are co-exhibitor*” and “*You want to share the exhibitor's booth as below: “PADI DIVE CENTER”* (select from the drop-down menu)
Please note, do not select PADI EMEA Limited
- Also click on “*Your registration fees should be charged to: “Directly to me”*”.
- On the “*Your contact details*” page, check the information you have already entered
- Then click on “*Submit my registration*”

B/Process for exhibitors who have not exhibited at the show in the last 10 years:

- On the next page, enter your details to receive an email with an access code that will allow you to continue on this page.
If you do not receive the code, please check your spam folder.
- On the "Choose Registration type" page, click on "You are co-exhibitor" and "You want to share the exhibitor's booth as below: **"PADI DIVE CENTER"** (select from the drop-down menu)
Please note, do not select PADI EMEA Limited
- Also click on "Your registration fees should be charged to": "Directly to me".
- On the "Your contact details" page, fill in all the required fields.
- Then click on "Submit my registration"

From this point onwards, you will be pre-registered.

To confirm your registration request, you will need to send us a deposit of €568.56.

4/ Your Custom Graphics

As mentioned, you have one custom graphic to provide for your booth.

You must send us a **high-resolution PDF file** so we can print your graphic and deliver it to the booth.

- ➔ **For the partition**, the graphic, and therefore the file you need to send, must be exactly **940 mm × 2,246 mm**.

Please note that the counter front graphic will be handled directly by PADI, so you do not need to provide any file for this element.

At the request of PADI EMEA, please include the PADI logo in your visuals.

If files are received after this date, you will automatically be charged an additional fee of €84.00 (excluding VAT).
